#### NATURE OF WORK

Under supervision of the Assistant and Public Works Manager operates equipment involved in maintenance, repair and construction of County roads and facilities. Perform related duties as assigned.

#### SUPERVISION RECEIVED

Work is performed under direction of a higher level of authority.

#### SUPERVISION EXERCISED

May be assigned to, supervise prison inmate labor crew, and persons sentenced to perform community service for others.

## **EXAMPLES OF WORK PERFORMED / ESSENTIAL FUNCTIONS**

ON ASSIGNMENT TO BUILDING, MAINTENANCE AND GROUNDS: Performs semi-skilled work of moderate difficulty maintaining and repairing County buildings and facilities; maintains daily logs, inventory, and inspection and construction records and prepares reports; performs general maintenance and repair work including carpentry, masonry, electrical, plumbing, and repair of air conditioning and heating units; participates in inventory control; performs other work as required or assigned.

ON ASSIGNMENT TO PARKS: Care for lawns, trees, and shrubs; maintain playgrounds; clean buildings; and keep parking lots, picnic areas, and other public spaces free of litter. Apply pesticide through sprays, dust, or vapors.
