AGENDA AND MINUTES

In attendance: Board of Supervisors members: Chairman, David Gomez Member Ron Campbell, Member and William Wearne, Member. Also present were Gary Griffith, County Attorney, and Bianca Castañeda, Clerk of the Board

1. Call to Order

Chairman David Gomez called the meeting to order at 8:00 a.m.

a. Pledge of Allegiance

Supervisor Wearne led those present in the pledge.

b. Call to the Public

Erin Miller, County Recorder introduced new stickers and cameras for election preparation. Austin Adams introduced a new employee in the Boards Office, Sara Wright. Sheriff Eric Ellison reported on ongoing drug issues, increased traffic violations, and the installation of cameras to combat crimes. The jail currently houses 17-20 inmates with plans to fully staff the jail.

- 2. PUBLIC HEALTH SERVICES DISTRICT – the Board of Supervisors will convene as the Board of Directors of the Greenlee County Public Health Services District and will reconvene as the Board of Supervisors following consideration of the following items:**
 - a. Consent Agenda**
 - i. Clerk of the Board: Consideration of approval of Public Health Services District expense warrants in excess of \$1,000.00.**

Upon motion by Supervisor Campbell, seconded by Supervisor Wearne, and carried unanimously, the Board approved the Public Health Services District Consent Agenda as presented.

- 3. FLOOD CONTROL DISTRICT – the Board of Supervisors will convene as the Board of Directors of the Greenlee County Flood Control District and will reconvene as the Board of Supervisors following consideration of the following items:**
 - a. Consent Agenda**
 - i. Clerk of the Board: Consideration of approval of Flood Control District expense warrants in excess of \$1,000.00.**

Upon motion by Supervisor Campbell, seconded by Supervisor Wearne and carried unanimously, the Board approved the Flood Control District Consent Agenda as presented.

- 4. Milton Brett Jensen, Chief Deputy**
 - a. Discussion/Action regarding approval to purchase twelve (12) cameras and twelve (12) POV lenses with mounts for Sherriff's Office personnel from Axon Enterprises, Inc., as a sole source provider.**

Chief Deputy Jensen presented a proposal to purchase 12 new Axon body four cameras for the Sheriff's Office. The new cameras will offer better technology, including translation capabilities. The purchase will be funded by a grant, with payment spread over four or five years.

Upon motion by Supervisor Wearne, seconded by Supervisor Campbell and carried unanimously, the Board approved the purchase of 12 cameras and 12 POV lenses with mounts from Axon Enterprises, the sole source provider in the amount of \$16,594.33

- 5. Eric Ellison, Sheriff**
 - a. Discussion/Action regarding permission to purchase 40x60 metal building for evidence building and office space for the Sheriff's Office.**

Sheriff Ellison requested approval to purchase a steel building. Three bids were received; his recommendation is to purchase from All American Steel LLC.

Upon motion by Supervisor Wearne, seconded by Supervisor Campbell and carried unanimously, the Board approved the purchase of a metal building from All American Steel, LLC in the amount of \$35,054.00.

6. Rene Ontiveros, Chief Financial Officer and Bianca Castañeda, Clerk of the Board

a. Review of County Sales Tax Revenues

Mr. Ontiveros discussed state shared sales tax revenues at \$550,935.00 exceeding the budget by \$1.4 million and half cent county excise tax revenues at \$139,000 above budget

Calendar and events were discussed, the board moved the next meeting to Wednesday, November 5th at 8:00 a.m.
