## AGENDA AND MINUTES

In attendance: Board of Supervisors members: Richard Lunt, Chairman, David Gomez, Member (Via Telephonic), and Ron Campbell, Member. Also present were Gary Griffith, County Attorney, Derek Rapier, County Administrator, Austin Adams, HR Director, and Bianca Castañeda, Clerk of the Board

#### 1.) Call to Order

Chairman Richard Lunt called the meeting to order at 8:00 a.m.

### A. Pledge of Allegiance

Supervisor Campbell led those present in the pledge.

#### B. Call to the Public

Mr. Rapier responded to call to the public and stated the Landfill Crew recently went through an inspection with no deficiencies, which is rare. He acknowledged and thanked Mr. David Manuz and his crew

- 2.) PUBLIC HEALTH SERVICES DISTRICT the Board of Supervisors will convene as the Board of Directors of the Greenlee County Public Health Services District and will reconvene as the Board of Supervisors following consideration of these items:
  - A. Consent Agenda
    - 1. Clerk of the Board: Consideration of approval of Public Health Services District expense warrants in excess of \$1,000.00

Upon motion by Supervisor Campbell, seconded by Supervisor Gomez, and carried unanimously, the Board approved the Public Health Services District Consent Agenda as presented.

- 3.) FLOOD CONTROL DISTRICT the Board of Supervisors will convene as the Board of Directors of the Greenlee County Flood Control District and will reconvene as the Board of Supervisors following consideration of these items:
  - A. Consent Agenda
    - 1. Clerk of the Board: Consideration of approval of Flood Control District expense warrants in excess of \$1,000.00

Upon motion by Supervisor Campbell, seconded by Supervisor Gomez and carried unanimously, the Board approved the Flood Control District Consent Agenda as presented.

- 4.) Irvin Talley, Greenlee County Chief Probation Officer and Derek Rapier, County Administrator
  - A. Discussion/Action regarding funding for salary increases for Greenlee County Probation Staff.

Mr. Irvin presented a power point and discussed how local probation office's budgets are set at the state level for each probation office based on the previous year's salaries and cost. He explained the funding change in legislation for probation offices and stated he is still waiting on approval from the state, with a 5% raise for his employees to be included in the budget for the upcoming year. A 5% raise will cost \$23,000.00 total including ERE's.

Mr. Rapier explained the structural change in the legislation and the risk to the county regarding future funding and recommended the board to front the \$23,000.00 for the salary increases.

Upon motion by Supervisor Campbell, seconded by Supervisor Gomez, and carried unanimously, the board moved to approve funding for the probation department raises at 5% with the amounts outline by Mr. Talley's presentation with the remainder coming from the county general services fund.

# 5.) Monica Miller, Clifton Social Club PresidentA. Presentation regarding the Festival of Lights Funding

Ms. Miller explained the town of Clifton will no longer host the Festival of Lights, and stated the Social Club will take over the event. Marina Morales Chairperson on the committee explained the organization in a nonprofit, she discussed the plans for the festivities, would like to keep the same traditions and make new ones. The town of Clifton will be donating \$4,000.00. Mr. Rapier recommended staff to work with the committee to come up with an exact donation amount.

# 6.) Eric Bejarano, Director, EAC Small Business Development Center, representing the Gila Valley Small Businesswomen of the Year Committee A. Presentation and consideration of adoption of a Proclamation regarding National Women's Small Business Month

Mr. Bejarano, discussed the Small Businesswomen of the year program, the program serves Greenlee, Graham Counties and the Gila Valley and recognizes women who own small business owners.

Upon motion by Supervisor Campbell, seconded by Supervisor Gomez and carried unanimously, the Board approved the adoption of the Proclamation as presented.

# 7.) Tony Hines, Public Works Fleet/Facilities and Derek Rapier, County Administrator

A. Presentation regarding alleged wiring issues in and maintenance of vehicles assigned to the Sheriff's Office.

Mr. Hines presented a PowerPoint presentation and explained pictures of vehicles assigned to the Sheriff's office that were presented to the board in a previous meeting. Mr. Hines gave a brief explanation of each picture to assure maintenance and wiring are not an issue in the Public Works Fleet Department. After speaking to upfitters who install add-on equipment to law enforcement vehicles regarding the alleged issues and wiring, they expressed no concerns. Mr. Hines also briefed the board on and expressed his confidence in his employees' experience in working on these kinds of issues.

Mr. Rapier presented a PowerPoint and discussed issues among elected officials and county piers. He addressed conflicts and acknowledged the way things are handled can change.

The Board commented on Mr. Rapier's presentation, well received and gave their appreciation to his discussion.

# 8.) Derek Rapier, County Administrator and Bianca Castañeda, Clerk of the Board

### A. County and State budget and legislative issues

Mr. Rapier discussed county and legislative issues, county will play defense and not have any items for the CSA agenda for next week's summit. Because there will not be as much money in the State budget, new spending initiatives will most likely not be heard. Mr. Rapier will present the County's first quarter revenues distributions data at next meeting to begin analyzing how the current fiscal year's budget is doing.

Will set CSA legislative agenda next week. Vice President Danny Smith with small counties resigned from the Graham County Board of Supervisors so a seat will open on the CSA Board. Medium county Caucus will vote on a 3<sup>rd</sup> Vice President position. Two positions will be voted on at the next meeting. He also attended WIR, which focused on local issues.

### 11.) Work session - Greenlee County Fairgrounds Park Development

Board Staff and department heads lead a discussion by the Board and staff to reimagine how the county fairgrounds could be used to accommodate different recreational activities including a softball/little league complex, splash pad, walking trails, and other potential uses. The Board gave their ideas on development and directed staff to work with stake holders to continue the development fairground use concepts.
