Mr. Rapier explained that the county has researched all available records and has found no evidence that the county has ever had any ownership interest of any kind in a cul-de-sac in Loma Linda known as Calle Jon. The proposed resolution clarifies the issue, Mr. Rapier's recommendation is that the board adopts the proposed resolution demonstrating that the county has not ownership interest in the cul-de-sac.
