AGENDA AND MINUTES

In attendance: Board of Supervisors members: Chairman, David Gomez Member Ron Campbell, Member (via zoom) and William Wearne, Member. Also present were Gary Griffith, County Attorney, Derek Rapier, County Manager and Bianca Castañeda, Clerk of the Board

1. Call to Order

Chairman David Gomez called the meeting to order at 7:30 a.m.

a. Pledge of Allegiance

Supervisor Wearne led those present in the pledge.

2. Derek Rapier, County Administrator

a. Discussion/Action to consider purchasing an ambulance from RedSky Emergency Vehicles, as a Sole Source Vendor purchase.

Mr. Rapier provided a brief history of the ambulance purchase, mentioning that the board approved the purchase in fiscal year 2022-2023 but the ambulance has not yet arrived after nearly 3 years. Introduced the specifications of the Red Sky Ambulance with a cost of \$243,393, including taxes and the addition of a refrigerated box for medication

storage, which is an additional cost of \$3,075. Recommendation is to proceed with the purchase citing sufficient funds in the Capital Improvement Fund since the value of the ambulance exceeds \$100,000 and had an expected life of more than five years. There is sufficient budget capacity in the Capital Improvement Fund from unexpended money from capital projects.

Upon motion by Supervisor William Wearne, seconded by Supervisor Campbell, and carried unanimously, the Board approved to purchase the new Ambulance in the amount of \$250,000 from Red Sky Emergency Vehicles as a sole source vendor.

3. Adjournment

There being no further business to come before the Board of Supervisors, the meeting was adjourned at 7:40 a.m.
