In attendance: Board of Supervisors members: David Gomez, Chairman, Ron Campbell, Member and William Wearne, Member Also present were Gary Griffith, County Attorney, Derek Rapier, County Administrator, and Bianca Castañeda, Clerk of the Board

1. Call to Order

Chairman David Gomez called the meeting to order at 8:28 a.m. The meeting began late due to technical problems with the link to the County's YouTube channel.

a. Pledge of Allegiance

Supervisor Wearne led those present in the pledge.

b. Call to the Public

Martha Lujan, social performance and town site manager in Morenci, presented information on an upcoming project. Drilling will be conducted in Clifton and near the Freeport guest house, causing noise and light disturbances. Ms. Lujan offered to address any concerns or questions about the project and also mentioned Earth Day activities.

Sheriff Ellison reported on the drowning of two children in Eagle Creek. He highlighted the increased popularity of Eagle Creek and the Frisco area among tourists and recreationalists. He explained that the Sheriff's office does not have ATVs necessary to access the area of the incident. Private citizens transported the first responders to access the remote area on the river during the incident.

Mr. Rapier proposed expanding vehicle purchasing options to include additional acquisition options such as online purchases, leases, and new acquisition options that may come online in the future. The old policy limited purchasing to bidding and state contracts. The new policy would allow for bidding, lease purchase options, and other methods that are beneficial to the county.

Upon motion by Supervisor Campbell, seconded by Supervisor Wearne and carried unanimously, the Board approved the policy change to expand vehicle purchasing options.

Mr. Rapier provided an update on the state budget and revenue forecasting. He reassured that the county's budget is in good shape and will meet its needs. He mentioned potential budget adjustments and the need for work sessions to discuss them.

Chairman Gomez attended small counties, hosted by Santa Cruz County. Representative Gail Griffith spoke on water issues. He also attended ECO, wolf issues were discussed. CSA meeting, in attendance was Director of the State Forestry Tom Torres and Director of ADWR Thomas Buschatzke, presented forest topics, lack of moisture, fire danger and how they have a handle on the issues.
