**1. Call to Order**

Chairman David Gomez called the meeting to order at 7:03 p.m.

**2. Work Session: Discussion regarding Greenlee County Fairgrounds project**

The Board discussed the feasibility of temporary lighting solution for the Little League season using portable light plants. Mr. Rapier noted the cost per unit is \$1,000 per month, totaling \$3,000 for a three-month season. Suggestions included getting one field game ready with permanent lighting and using temporary lights as a backup. The Board was informed about the possibility of using cooperative buying agreement, which could expedite the process. An additional alternative included using wood poles and temporary lights. The goal is to have at least one field ready by March 3, with contingency plans in place if delays occur.

Travis Bejarano a Duncan resident and associate of the Duncan Little League, proposed having at least eight light plants for better coverage, he mentioned the start of practice in mid-February and the flag ceremony and grand opening on March 3.

Mr. Rapier thanked all involved for their participation and outlined the next steps, including gathering quotes from the purchasing cooperative vendors. The Board agreed to reconvene for a special meeting to make a formal vote on the lighting solution as soon as the additional requested information could be gathered. The meeting adjourned with a consensus on the plans on how to move forward and a commitment to follow up on the vendor quotes.

There being no further business to come before the Board of Supervisors, the meeting was adjourned at 7:30 p.m.
