1. Invitation

Greenlee County invites qualified vendors to submit sealed proposals for the purchase and delivery of one (1) new, current model year or newer, 1/2-ton, four-wheel-drive crew cab pickup truck with four full-size doors and a silver exterior. The vehicle shall be suitable for public works, facilities, fleet, and general municipal operations.

2. Scope of Work

The successful vendor shall furnish, deliver, and provide all required documentation for one complete and operational 1/2-ton 4x4 crew cab pickup truck. The proposal shall include all standard manufacturer equipment, required options, warranty information, delivery schedule, and any exceptions to these specifications.
